We have another set of new classes and programs on the schedule for the fall in addition to our regularly scheduled <u>Basic Pistol</u>, <u>Beyond the Basics</u>, and <u>CHL courses</u>. On June 20th, we'll visit the **Alamo Defensive Pistol (IDPA) club** at the Blackhawk Range in San Antonio to demonstrate our scenario-based training program. After the IDPA match, we'll run scenarios similar to those in <u>AT-II</u>. The demo is free to anyone shooting the match. For more info contact **Reggie Hock** (210) 680-9142.

On the last Wednesday of each summer month, we'll offer intermediate courses at **Red's Indoor Range**. Beyond the Basics is scheduled for June, and in July we'll debut our new <u>Tactics 101</u> course (similar to the morning lecture of AT-II). Introduction to Low-Light Shooting will be offered in August.

The popular Advanced Training weekend, and an NRA Instructor Certification class will both take place in August. The instructor class follows the Texas DPS Concealed Handgun Instructor course the first week of August. Our course will certify students as instructors in Home Firearm Safety, Basic Pistol, First Steps Pistol, and Personal Protection. Penny Riggs will complete NRA Training Counselor certification in July and will assist with the class.

On September 9th, we'll offer a special short course, <u>Lessons from the Street</u>, taught by Austin law enforcement officer, **Paul Ford**. Paul Ford is in the business of confrontation: During his 14-year career as a police officer he has spent the last 10 on the SWAT team, including duty as Entry Team Leader and Training Coordinator. Having dealt with some of Austin's most dangerous criminals and survived multiple deadly force situations, he is willing to share some of his experiences and perspectives on what he believes are critical aspects of self-defense. The lecture will cover perspectives on critical incidents - how to prepare and how to win in a deadly confrontation.

Adjunct instructor **Wendell Joost** will return September 11th as co-instructor for <u>Advanced Training III</u>. AT-III will focus on one-handed and "wounded shooter" drills, and will include more flashlight and low-light live-fire exercises. Completion of AT-I and IA or similar training is required for entry into this class.

KR Training and the Schaefer Training Academy will host a special Large Bore Revolver Seminar, put on by hand cannon maker **John Linebaugh**. This seminar, on September 18th, will include a 2-hour lecture, steak dinner, and range session. Each participant will get to shoot 20 rounds of ammunition through John's .475 and .500 Linebaugh wheelguns for the bargain price of \$25. In October, our training schedule is light because we will be shooting the Coors/Taurus Texas Paper and Iron Championship in Midland and the USPSA Limited National Championship in Las Vegas. **Penny Riggs** will represent the KR Training team and I'll be a Range Officer at the National match.

Another <u>Home Defense Tactics</u> course will be offered in Novemeber, and **Wendell Joost** will return to teach our special Y2K edition of <u>Defensive Shotgun I.</u>

In addition to teaching, KR Training team members are still competing and training: Glenn Garvey recently completed his EMT certification. Penny Riggs and John Kochan will complete the USPSA level I Range Officer school in June. Glenn, Penny, John, Kelli Mathiason and Wendell Joost were all recently certified as NRA Refuse to Be a Victim instructors. Contact us if you are interested in this "self defense strategies" class that addresses home, auto, and personal safety.

KR Training is a match sponsor for the <u>SDSI</u> <u>Lone Star Invitational Tactical 3-gun match</u>, being held in the DFW area June 26 and 27. The match will include 6 stages: 2 pistol, 2 rifle, and 2 shotgun, and 6 one-hour clinics on topics like low light shooting, precision rifle, and other defensive issues. A free entry to <u>Massad Ayoob's LFI-I class</u>, to be offered at SDSI in October, will be given away, along with several Beretta firearms and gift certificates for SDSI and KR Training classes. We'll address the Austin MENSA group about "smart gun" technology on September 13th, and participate in a UT Federalist Society/Women's Law Caucus forum during the fall semester.

KR Training "distinguished professor" **Glenn Meyer** has put together a new book called <u>CyberGuns</u> that lists all the firearms resources available on the Internet. The response to the <u>Street and Vehicle Tactics</u> course taught by **Greg Hamilton** and the **InSights** staff was astounding. It was the largest class we've offered, and generated so much interest that InSights instructors will return to Austin, Dallas, and Houston to offer a variety of courses. They plan to offer <u>Defensive Folding Knife I</u> and <u>Unarmed Self Defense</u> for KR Training in Spring 2000. The knife course is a one-day class and will be offered on a Friday, with the two-day Unarmed Self Defense course held over the weekend. In Fall 2000, they will offer <u>Defensive Folding Knife II</u>.

By special arrangement with Austin Armor Products (AAP), 8"x10" body armor panels are available and suitable for use in a briefcase or backpack, for \$110 each. These panels are not NIJ-rated but they are made of 30-ply spectra (a level II-A vest only has 14-17 layers). In addition to having utility as body armor they can be used to create a "safe area" for dry firing, clearing guns in apartments, etc. Orders for the panels must be placed through KR Training by July 1.

Also through AAP, we have purchased a supply of **ASP "Sapphire" personal lights**. The Sapphire is an amazing flat pocket light, with a 100,000 hour lifetime from a single 3 volt lithium battery. ASP's guarantee on this product includes lifetime battery replacement and lifetime crystal replacement. The Sapphire is waterproof,

shockproof, rugged, and comes in several housing colors. It has a quick release clip that easily attaches to belt loops, coat zippers, keychains, etc. They are 3" x 1" x 0.3" thick and sell for \$14.

By special request, we are also planning another order of **KR Training shirts and hats**. The shirts are 'cream'-colored 100% cotten shirts, with button down collars, in long or short sleeve versions, with a KR Training logo embroidered in navy blue. The hats are heavy khaki baseball caps, with navy blue bills and the KR Training logo embroidered in navy. Shirts are \$25 and hats are \$15. **Orders must be placed by July 1**.
